3. I understand that JMJ follows the teachings of the **Roman Catholic Church**, under the **Bishop of Rome**. Non-Catholics are welcome, but must respect our Catholic traditions. _____ (Initials)
4. While attending JMJ events, or while communicating on the JMJ email list, I will **NOT** share information that is contrary to the teachings of the Roman Catholic Church. _____ (Initials)
5. The information contained in the JMJ Member's directory is solely for the purpose of fostering the community within JMJ. I will not use the information in the directory for any other purposes. _____ (Initials)
6. I have read the JMJ Yahoo email posting guidelines and agree to abide by them. _____ (Initials)
